Pennrose Closes on Purchase of Mary D. Stone



Pennrose and the Town of Auburn are pleased to announce that Pennrose has secured all financing and closed on the purchase of the former Mary D. Stone Elementary School. Construction has begun on the project, a 1.25-acre parcel and 3-story 1920s era historic school building which will be

developed into 55 units of senior housing. The redevelopment plan includes the renovation of the original school building, demolition of later built wings, and construction of a new addition. The completed structure will include amenity space and community rooms available to the Town for meetings and events.

The development will include 55 total units comprised of studio, one -bedroom, and two-bedroom apartments. Eighty percent of the units will be for seniors at or below 60% of the area median income (AMI). The additional 20% of units will be at market rate rents. Community amenities include a community room, meeting room, and laundry rooms. As part of the development plan, Pennrose has contributed \$25,000 to the Town for new equipment for the playground which will remain behind the building and owned by the Town for resident's continued use. Pennrose will also be adding landscaping and benches to enhance the area.

Pennrose was selected as the developer following a Request for Proposals issued by the Town seeking to redevelop the vacant school property with a preference for senior housing. "Since being selected for the project, Pennrose has worked closely with the Town of Auburn to progress the design and financing plan," said Charlie Adams, Regional Vice President at Pennrose. "We see great opportunities here to create some intergenerational experiences for our residents and the community. This is an exciting step in the first of two pivotal projects for the community."

"On behalf of the Town of Auburn, I want to congratulate Pennrose on securing all of the necessary financing to advance this project," said Town Manager Julie Jacobson.

cials, including Congressman McGovern, Senator Moore, Representative Frost, the Board of Selectmen, the Historic Commission, the Elementary School Re-Use Advisory Committee, the Planning Board and the Zoning Board of Appeals, Town Meeting members, as well as the many department heads and employees who have worked diligently to bring this property to closing and facilitate the redevelopment of the Mary D Stone School into much-need affordable housing for seniors. We are thrilled that the redevelopment of the property is underway and we look forward to continuing to work with Pennrose officials as the project moves forward."

To gain community input, an Aging-in-Place Charrette, co-sponsored by Enterprise Community and Pennrose, was hosted in September 2017 at the Auburn Town Hall. Invitees included town officials, the Auburn Council on Aging, the Elder Services of Worcester, Fallon Health (a PACE provider), the Lorraine Gleick Nordgren Senior Center, town department heads, and the MA Executive Office of Elder Affairs. The well-attended charrette allowed the development team to rely on the expertise of the individuals to brainstorm and prioritize important elements of quality senior housing that addressed isolation issues of seniors and promoted mental and physical health. The goal was more than just creating units to meet the local demand for affordable housing, but to make these safe, welcoming homes where seniors can continue to be active members of the community. charrette a prioritized list of needs and wants for the future developments was created. Preliminary plans were also been presented at the Senior Center to solicit input from the seniors. "Now more than ever we need this kind of housing," says Timothy I. Henkel, Principal and Executive Vice President. "This housing offers seniors who are currently living in unhealthy housing conditions like basements, overcrowded situations, or simply in isolation, access to safe and secure housing which will enhance their mental and physical well-being."

"We are so appreciative of the support from the Commonwealth that begins with Governor Baker and Lieutenant Governor Polito and the dedicated staff at the Department of Housing and Community Development, MassHousing, and CEDAC," says Adams. "Equally important is the support from Secretary of State William Galvin whose office provided critical needed Historic Credits."

Pennrose and the Town of Auburn also have plans to develop the former Julia Bancroft School into a 60-unit, senior, mixed-income rehabilitation project. That site is 3.3-acres with an existing 37,000

Financing for the project includes 9% Federal Low Income Housing Tax Credits and State Low Income Housing Tax Credits through the Department of Housing and Community Development (DHCD). DHCD has provided HOME, Housing Stabilization Funds, and Affordable Housing Trust Funding addition to Project Based-Section 8 rental housing assistance to make units affordable seniors. Massachusetts Historic Commission provided State Historic Tax Credits. Pennrose's equity and debt partners include CREA, Dorfman Capital, BlueHub Capital, Massachusetts Housing Part-

a 60-unit, senior, mixed-income rehabilitation project. That site is 3.3-acres with an existing 37,000 square foot, 2-story historic building. The redevelopment plan includes the renovation of the original 1920s historic structure while demolishing the later addition and replacing it with a new, 3-story structure. Pennrose currently has an application for funding for the Julia Bancroft project pending with the State.

Pennrose began construction in late June. There will be no access to the field or playground during the construction period due to safety concerns and regulations. The project is expected to be completed by September 2021. Throughout construction, Pennrose Properties will provide the public updates regarding their progress. Town Administration will also routinely post updates on Auburn-

Annual Town Meeting Held Outside on High School Football Field



Covid-19 has affected all of us and has had tremendous social and economic impacts across the globe. Here in Auburn, our municipal operations have been impacted as well, as we have had to develop new strategies and new measures to ensure that we continue to provide essential and critical services to our community.

As a result of emergency legislation that was passed into law in Massachusetts, the Board of Selectmen voted to postpone the Annual Town Meeting, originally scheduled for May 5th, to Tuesday, June 2nd. Under the Governor's Order, the 10-person maximum gathering requirement does not apply to legislative bodies, which enables towns to move forward with Annual Town Meetings. In order to create an environment that was safe for all attendees and participants, the Annual Town Meeting was held on June 2nd outdoors on the football field at the High School at 6:00 PM (changed from the usual 7:00 PM to hold the Meeting in daylight). Fortunately, we did not need to postpone to any of the rain dates that had been scheduled, although we did experience a brief rainfall early in the Meeting.

Town administration put several measures into place to ensure the health and safety of Town Meeting Members and town employees. Those measures included:

Holding the meeting outside on the football field at the Auburn High School as opposed to indoors in the Auditorium as the football field was large enough to allow us to arrange for seating that, at a minimum, meets the CDC's and the State's 6 foot social distancing guidance.

For any Town Meeting Member who could not walk onto the football field or prefers to remain in their own vehicles, we provided parking spaces available near the football field so those members can remain in their cars yet still hear the discussion on the loud speakers or listen to it through their car radios on 1610 AM through which we streamed the audio during the Meeting. We provided paddles for those in their cars to hold up outside of their car windows to indicate either a "Yes" or 'NO" vote. We had counters walk through that portion of the parking lot to count the votes for each warrant article.

The check-in area was marked with six-foot distancing lines to maintain safety and compliance with the 6 foot distancing guidance. Since the Governor's Order requiring face coverings went into effect on May 6th wherever so-

cial distancing is not possible, and although we were outside with seating at least 6 feet apart, we asked all attendees and participants to wear face coverings as an extra precaution. We supplied re-usable surgical masks for anyone attending the meeting who needed a mask. We also supplied disposable gloves for anyone attending who wanted to wear gloves.

We removed any non-essential, non-time sensitive articles from the Annual Town Meeting Warrant. The 30 remaining articles were critical to continued municipal operations. That included three articles authorizing easements that were necessary in order to close on the sale of the Mary D. Stone property to Pennrose Properties to facilitate the redevelopment of the property into 55 units of senior housing.

To shorten the meeting, we eliminated the presentations normally given under Article 1 by the Town Manager, School Superintendent, and any boards, commissions or committees. The Assistant Town Manager/CFO still provided a brief presentation on the FY21 budget under Article 3. We provided hard copies of Town Manager Julie Jacobson's presentation, School Superin-

tendent Dr. Maryellen Brunelle's presentation, and Assistant Town Manager/CFO Ed Kazanovicz's presentation in the packets mailed to Town Meeting members along with the Annual Town

Meeting Warrant. These presentations were also posted on the Town's website at www.auburnguide.com and each presentation was been taped and made available to view on the Town's website. We also encouraged Town Meeting Members to call town administration if they had any questions on warrant articles in advance of Town Meeting. Individual calls were made to every town meeting member two weeks ahead of the Town Meeting to explain the precautions and safety measures that would be in place and to ask if the mem-

We were very pleased to welcome 97 Town Meeting Members that evening, exceeding the quorum of 80 that was required. In fact, the 2020 Annual Town Meeting was one of the highest attended Town Meetings in recent years. We thank those Town Meeting members who participated for their support and commitment to the Town of Auburn.

ber planned to participate by either sitting on the football field or remaining in their car.

In order to continue to provide services and be accessible to the public while remaining in compliance with the State's Reopening Plan, Town Administration has installed a Drive-Through Service Kiosk outside at Town Hall through which citizens can drive up to the window, remain in their vehicles, and conduct certain transactions and business.


The Drive-Through Kiosk opened on Monday, June 1st. The hours of operation for the first week were limited to Monday through Friday 8:30 AM to 12:00 Noon to gauge the demand and refine its operations. We are pleased to say that many residents and businesses used the Kiosk during that first week and the feedback from the public has been extremely positive. As a result, we expanded the hours of the Drive-Through Kiosk. The Drive-Through Kiosk hours are Monday through Thursday 8:00 AM to 4:00 PM and Friday 8:00 AM to 1:00 PM.

In addition to the Kiosk, we installed a new window at the Treasurer/Collector's Office through which we can service the public with outside access. The Treasurer/Collector's Outside Service Window is located behind Town Hall near the back entrance door, accessible via the handicapped ramp. Residents can pay bills, including in cash, at this window. Employees from the Treasurer/ Collector's Office will also be available to answer inquiries at this window. The Treasurer/ Collector's Outside Service Window began limited operations on Monday, June 1st. On Monday, June 8th those hours were expanded to the regular operating hours of Town Hall (although Town Hall and other municipal offices remain closed to the public). The hours of operation of the Treasurer/Collector's Outside Service Window are: Monday 8:00 AM to 7:00 PM., Tuesday through

All persons doing business at the Drive-Through Kiosk or Outside Window at Treasurer/Collector's Office must wear face coverings unless health conditions prevent the use of masks. Residents, businesses and property owners can continue

handicapped ramp, next to the Outside Window at the Treasurer/Collector's Office near the back door of Town Hall. These additional services provide an opportunity for residents, businesses, property owners and visitors to conduct business at Town Hall even while the building remains

closed to the public in addition to the ability to conduct business on-line and by telephone, the latter of which can be done during normal business hours.

Virtual Groundbreaking Event held for Mary D. Stone Apartments



A virtual groundbreaking event was held on July 27th to mark the start of construction on the Mary D. Stone Apartments, a major milestone in the redevelopment of the former Mary D. Stone Elementary School into much needed affordable housing for our seniors. The Mary D. Stone Apartments will provide a quality and safe housing option for those seniors who wish to remain independent and age in place while still being a part of the Auburn community, without having to worry about the upkeep and cost of a single family home. In addition to quality housing for seniors, its economic impact includes tax revenues that will be generated from putting the building on the tax



rolls that can be invested back into the community. The virtual event, a first for most of us, was in itself significant, as it proved that we can conduct important business and recognize milestone accomplishments in a safe and responsible manner while upholding the Baker-Polito Administration's Reopening Plan for the Commonwealth.

Speakers at the virtual groundbreaking, which had 60 attendees through the Zoom platform, included Lt. Re-Opening Restaurants During COVID-19

On June 8, Governor Baker issued an order outlining details for Phase II of the Commonwealth's reopening plan. Part of the order permitted restaurants to provide outdoor dining service with restrictions upon the start of Phase II, which began June 8th. Additionally, in order to provide improved opportunities for outdoor table service, the order issued by Governor Baker also provided flexibility to local licensing authorities to grant approval for a temporary extension of premise for the sale of

alcoholic beverages for on premise consumption.

Town Administration acknowledges the hardships businesses face due to the ongoing Covid-19 pandemic and we are all learning how to adapt during these uncertain times. Town Administration and the Board of Selectmen took proactive measures to ensure that businesses are supported during the reopening plan as much as possible. Town Administration is committed to working with local businesses to provide them guidance regarding public health and safety requirements so they can begin to

In preparation for Phase II, Town Administration worked diligently to prepare a comprehensive checklist and process to reopen local restaurants for outdoor dining as quickly and smoothly as possible. The reopening requirements and checklist were created with the input from the Development Coordinating Group, which is comprised of department heads from the Department of Development

and Inspectional Services, Fire Department, Police Department, Department of Public Works and Water District. The local requirements for outdoor dining were created with safety and business friendliness as top priorities.

On June 4th, The Board of Selectmen, in accordance with Governor Baker's Covid-19 Executive Order #35, granted approval of extension of premises for the holders of liquor licenses upon review of Town Administration and approval of the Building Commissioner and Director of Public Health. Additionally, the Board of Selectmen granted approval for the service of food and outdoor dining for holders of common victualler licenses, conditional upon the review of Town Administration and approval from the Building Commissioner and Director of Public Health. The Board of Selectmen also

voted to waive any associated local fees with these applications in order to reduce the financial burden on local business establishments. These votes ensured that Town Administration, most notably the Board of Health and Building Department, could move quickly to reopen restaurants for outdoor

The Department of Public Health and Building Department hit the ground running, and started inspections for outdoor dining on the first day of Phase II. Three local restaurants were open to patrons by June 9th. Five establishments are currently offering outdoor dining. The Department of Development and Inspectional Services has been working tirelessly to ensure that all the restaurants are following State and Local guidelines and safety standards to keep workers and patrons as safe as possible. As the State transitions into Part II of Phase II of the Reopening Plan, the Department will con-

tinue to work with businesses to safely allow indoor dining. Town Administration is continuously

adapting to all the new requirements from the State that are released weekly.

Town Administration would like to thank all of our local businesses for their dedication and hard work during this time. We truly appreciate you being a part of the Auburn community and we will continue to assist you as much as possible as the State continues to reopen.

Pool Safety Reminders from the Building Department

With the current Covid-19 Pandemic, more families are staying home and installing swimming pools to help entertain and occupy their children. In the first half of 2020, the Auburn Building Department has seen a record number of building permits for residential pools.

Statistically data shows us who is drowning and when and where these fatal drownings are happening – children, in the summer, at residential locations. This data underscores the need for all families to stay vigilant and practice water safety anytime they are in or around the water. Before heading to a pool this season, I implore everyone to sign the pool safety pledge by visiting https://www.poolsafely.gov/pledge/ and to take critical safety steps to ensure the joy of swimming does not turn tragic. By working

together, we can reduce fatalities. Parents and caregivers can follow Pool safety tips to keep children safer in and around the water by visiting https://www.poolsafely.gov/parents/safety-tips/

- Install a four-sided fence with a self-closing, self-latching gate around all pools and spas. Designate a Water Watcher to supervise children at all times around the wa-
- ter. This person should not be reading, texting, using a smart phone or be otherwise distracted.
- Learn how to swim and teach your child how to swim.
- Learn how to perform CPR on children and adults.
- Keep children away from pool drains, pipes and other openings to avoid entrapments.
- Ensure any pool and spa you use has drain covers that comply with federal safety standards and if you do not know, ask your pool service provider about safe drain covers.

CPSC also released an updated report on suction entrapment incidents in swimming pools, spas and whirlpool bathtubs. The key finding is that since the Virginia Graeme Baker Pool & Spa Safety Act went into effect in December 2008, there have been no reported fatalities involving a child being entrapped on a suction outlet cover in a public pool or spa.

Mosquitoes can spread diseases that make you very sick.

Wildlife Activity in the Spring & Summer



Spring & summer are busy seasons and many of our wild neighbors are hard at work providing for their families. With more mouths to feed, animals have to change their usual habits to be able to provide food and other necessities for their families, which may mean they are more active during times you may not typically see them. A healthy looking wild animal moving around normally during the day is not immediately concerning and can be completely normal.

That animal probably has babies, not rabies.

Signs and symptoms that are associated with rabies includes loss of muscle coordination, weakness, paralysis, seizures, difficulties breathing, difficulties swallowing, excessive drooling, abnormal behavior, abnormal aggression, and self-mutilation.

While at a safe distance, it can be a great learning opportunity and experience to be able to watch a wild family grow, thrive, and move away when they mature.

As always, we ask that you keep wildlife wild and to never provide a food source for our wild neighbors.

Veterans Services

VA expands funding for emergency response for Veterans experiencing or at risk of homelessness during COVID-19 pandemic

WASHINGTON — The U.S. Department of Veterans Affairs (VA) today announced it is allocating an additional \$400 million of its coronavirus relief funding to enhance the department's emergency

an additional \$400 million of its <u>coronavirus relief funding</u> to enhance the department's emergency relief response for Veterans experiencing or at risk of homelessness during the coronavirus pandemic.

The Coronavirus Aid, Relief and Economic Security Act (CARES Act) allocated \$17.2 billion for the Veterans Health Administration of which \$700 million is devoted to expanding services for and addressing the challenges faced by Veterans who are homeless or at risk of homelessness.

dressing the challenges faced by Veterans who are homeless or at risk of homelessness.

"The additional allocation of CARES Act funding will support the continuity of care of vulnerable Veterans during the COVID-19 pandemic," said VA Secretary Robert Wilkie. "With this additional funding, VA's Homeless Programs Office can provide more homeless prevention assistance and emer-

gency housing to make it possible for Veterans to maintain appropriate physical distancing and to ensure they are living in safe conditions."

The newly allocated funds will be used for the <u>Supportive Services for Veteran Families Program</u> (SSVF). SSVF offers several ways to secure housing for Veterans experiencing or at risk of homelessness

homelessness.

In total, \$602 million of coronavirus relief funding has now been allocated for this program, which will also help the <u>Housing and Urban Development-VA Supportive Housing Program</u> place Veterans in safe housing to isolate them from the virus.

Other coronavirus relief funding devoted to providing emergency shelter and supportive services for Veterans includes \$88 million for the <u>Grant and Per Diem Program</u> and \$10 million for the <u>Health Care for Homeless Veterans Program</u>.

VA is hosting a national webinar July 17 to support budgeting and planning for grantees of the SSVF funding. <u>Learn more</u> about how VA is working to protect Veterans during the COVID-19 pandemic

and about VA's homeless programs.

Municipal Vulnerability Preparedness

The Town of Auburn received a Municipal Vulnerability (MVP) Preparedness grant from the Executive Office of Energy and Environmental Affairs (EOEEA) in January this year. The project is twofold,

to develop best practices to protect the water supply area from contaminants and to develop "green" bridge design to replace culverts where Kettle Brook, the main tributary of the Blackstone River, crosses Sword Street. The project is well underway. A draft on the Best Management Practices has been available for public comment throughout June and will soon be finalized into a working document that will guide town, water district, and state officials as they improve stormwater management methods. Conceptual development of the green bridge is ongoing; discussions involve recycled materials, locally sourced materials, historical information, and pedestrian improvements. Conceptual plans will be used to guide the eventual design of a bridge to replace the failing culverts.

Later this summer as part of the current MVP grant, in partnership with Fuss and O'Neill and the Central Mass. Regional Planning Commission, there will be a public regional workshop. The workshop will promote lessons learned and challenges overcome with the MVP project. The goal of the workshop is to expand awareness of MVP project ideas, identify efforts that would enhance project benefits by going beyond the limits of political boundaries, and acknowledging the opportunities in partnering with other member communities to develop shared responses to climate change threats including identifying watershed based solutions.

The town is applying for the next round of MVP grants, with an announcement of award recipients in the coming months. The proposal will be to continue the work towards replacing the failing culverts at Sword Street. The scope includes field investigations, wetland delineation, geotechnical investigation, and hydrologic a

Sword Street. The scope includes field investigations, wetland defineation, geotecnnical investigation, and hydrologic and hydraulic calculations. The other aspect of the requested grant is to engage the community regarding water quality improvements to Leesville Pond. Leesville Pond is located partially in the Town of Auburn and partially within the City of Worcester and identified as an impaired water body by the Massachusetts Department of Energy and Environmental Protection (MassDEP) is listed on the Massachusetts 303d list for nutrients as well as organic enrichment/low dissolved oxygen, which are associated with high phosphorus loadings. The proposed multifaceted educational initiative will include residents in Auburn and Worcester.
